COVID-19 HEALTH & SAFETY POLICY

Investors Management Group, Inc. (“IMG”) is committed to following CDC and event location COVID-19 health and safety guidelines.

- Be fully vaccinated for COVID-19 fourteen days prior OR receive verification of a negative COVID-19 test result within the 48 hours immediately preceding the in-person event.

COVID-19 Liability Waiver and Release

The novel coronavirus and variants thereof (“COVID-19”) have been discovered and declared as a worldwide pandemic by the World Health Organization, the National Institutes of Health and the Centers for Disease Control and other public health authorities. COVID-19 can be extremely contagious and believed to be spread from person-to-person, by contact with contaminated objects and in the air. People can be infected and show few or no symptoms yet still spread the virus. COVID-19 may cause serious illness and/or death. Investors Management Group, Inc. (“IMG”) and IMG Parties cannot prevent you from becoming exposed to, contracting or spreading COVID-19 while attending or participating in an IMG Event or Activity. Any in-person interaction at an IMG Event or Activity may increase the risk of contracting and spreading the virus.

I hereby agree to and acknowledge my full understanding and acceptance of the risks explained above and accept them in order to participate in the IMG Event and related activities. I accept the risk of being exposed to, contracting and/or spreading COVID-19 in order to participate in the Event in-person.

I hereby forever release and waive all claims, actions and rights against Investors Management Group, Inc. and IMG Parties in connection with exposure, infection and/or the spread of COVID-19 related to my in-person participation in the Event and associated activities. I understand that this release and waiver means I give up my right to bring any claim or action, including for personal injuries, illness, disease, death, disability or property losses or any other loss that may be released and waived under applicable law, including, but not limited to claims of negligence, breach of contract or other cause of action, and I understand that this release and waiver prevents me from claiming and seeking damages in any way against IMG or its Parties, which such damages are known or unknown, foreseen or unforeseen, or that occur now or in the future.

- I am an adult of sound mind and competent to understand and enter into this waiver and release;
- I have read the terms of this waiver and release and fully understand and agree to be bound by the same;
- I agree that this waiver and release shall be governed by and construed in accordance with the laws of the state of California;
